***Acton Senator Seeks Wider Law vs. Stalkers by Cara Hogan, Sun Correspondent***

BOSTON, January 25, 2008 -- Sandra Berfield, a waitress from Everett, died in the explosion of a home-made bomb delivered to her house in 2000. The man who delivered the package had

terrorized and stalked her for two years. Massachusetts legislators passed Sandy's Law that same year, placing Berfield's name on a bill that raised penalties for stalking. But seven years later, victim-advocate groups say the law needs to be changed.

Victims of stalking shared their stories of violence and intimidation yesterday as part of the fifth annual Stalking Awareness Month this January to convince legislators to support a new bill which would protect citizens fully from stalkers.
